ORDER

WHEREAS the Nova Scotia Utility and Review Board (Board) issued an Order dated April 10, 2013 [2013 NSUARB 85], approving a Fuel Adjustment Mechanism (FAM) applicable to Regular General Route Public Passenger Service Rates in Motor Carrier License No. P02958 and Extra-Provincial Operating License No. XP02959 issued to Tri-Maritime Bus Network Inc. (Maritime Bus), and confirmation of the methodology for setting the base price under the FAM was issued by the Board in an Order dated April 7, 2014 [2014 NSUARB 66];

AND WHEREAS the FAM is calculated on a quarterly basis, effective the 15th day of April, July, October and January, reflecting the average New York Harbour spot price for ultra-low sulphur diesel fuel (ULSD) for the preceding three calendar months;

AND WHEREAS the average New York Harbour spot price for ULSD for the period January 1, 2010, through June 30, 2010 (base price), was 59.3 cents per litre;

AND WHEREAS the average daily spot price of ULSD for the period October 1, 2018, through December 31, 2018, was 75.1 cents per litre, producing an incremental increase in the cost of ULSD of 15.8 cents per litre above the base price;

AND WHEREAS the FAM permits Maritime Bus to assess a surcharge of 0.5% for each 2.5 cent per litre increase in the price of ULSD over the base price;

AND WHEREAS the fuel surcharge may increase or decrease as a consequence of the quarterly calculation, but does not result in a negative adjustment below the base price under the existing Board approved passenger rates;

AND WHEREAS the Board finds that the FAM results in a surcharge of 3.0% over the base price;

NOW THEREFORE IT IS ORDERED THAT the Board approves a surcharge of 3.0% on the Regular General Route Public Passenger Service Rates under Motor Carrier License No. P02958 and Extra-Provincial Operating License No. XP02959, issued to Maritime Bus, effective on and after 12:01 A.M. January 15, 2019, as set out in the attached Schedule "A", and this surcharge shall remain in effect until such time as any change is approved by the Board.
