**TAKE NOTICE** that **8177201 CANADA LTD. o/a SEESIGHT TOURS** is required to appear before the Nova Scotia Utility and Review Board on **April 24, 2024**, commencing at 9:00 a.m., in Hearing Room B, at 1601 Lower Water Street, 3<sup>rd</sup> Floor, Halifax, Nova Scotia, where it will have the opportunity of providing any evidence and/or arguments about whether Commercial Vehicle License Number CV03429 (License) should be cancelled, suspended, or other available resolution ordered, as a result of:

1. operating illegally contrary to the provisions of the License, the *Motor Carrier Act* and the *Board Public Passenger Motor Carrier Act Regulations*, by failing to cross a municipal boundary on its trips;
2. advertising, booking, and providing transportation services it was not licensed to perform; and


3. any other breaches which become known to the Board in the proceedings.

**AND TAKE NOTICE** that **SEESIGHT TOURS** is required to attend before the Board to give evidence and provide all records and documents about its services; in particular, its services from its standard area to Peggy's Cove, Halifax Regional Municipality, including, but not limited to, invoices for services provided and/or received, website itineraries and advertisements. It is required to file with the Board no later than April 17, 2024, any evidence it wishes to present at the hearing.

**AND FURTHER TAKE NOTICE** that if the company fails to appear before the Board on **April 24, 2024**, the hearing will proceed in its absence and the License may be cancelled, suspended, or other available resolution ordered.
