THE TOWN OF PICTOU, on behalf of its **WATER UTILITY** has applied for approval of amendments to its Schedule of Rates and Charges for Water and Water Services and amendments to its Schedule of Rules and Regulations

- You may request formal standing as an Intervener, subject to Board approval. This will allow you to present evidence or cross-examine witnesses. Your request must be received by the Board by Monday, February 5, 2024 and a copy of your written evidence by Monday, March 11, 2024.

Additional information about the matter is as follows:

For the unmetered rate, the current quarterly water bill is \$207.25, and it is proposed to increase to \$244.28 (a 17.9% increase) in 2024/25; \$271.61 (an 11.2% increase) in 2025/26; and \$277.85 (a 2.3% increase) in 2026/27.

For a 5/8 meter, residential customer, the average current quarterly water bill is \$144.97, and it is proposed to increase to \$163.54 (a 12.8% increase) in 2024/25; \$177.07 (an 8.3% increase) in 2025/26; and \$178.19 (a 0.6% increase) in 2026/27.

The Utility is also requesting increases for other metered services ranging from 13.5% to 17.6% in 2024/25; 8.8% to 11.1% in 2025/26; and 1.1% to 2.2% in 2026/27.

The annual fire protection charge paid by the Town, currently \$326,844, is proposed to increase to \$376,538 (a 15.2% increase) in 2024/25; \$437,484 (a 16.2% increase) in 2025/26; and \$456,592 (a 4.4% increase) in 2026/27.

Upon reviewing the Application, the Board, in its Decision, may determine that the proposed amendments should be as requested, higher, or lower.
