b) Effective 2025/26

For the proposed West Hants Regional Water Utility, for the 5/8" customers, the quarterly water bill is proposed to decrease from \$178.99 to \$178.60 (a 0.2% decrease) in 2025/26. For the 3/4" customer, there is no proposed change for the average quarterly water bill in 2025/26. For the other metered services, the proposed average quarterly water bill changes range from a decrease of 31.5% to an increase of 157.1% in 2025/26.

c) Effective 2026/27

For the proposed West Hants Regional Water Utility, for the 5/8" customers, the quarterly water bill is proposed to decrease from \$178.60 to \$176.20 (a 1.3% decrease). For the other metered services, the proposed average quarterly water bill increases range from 1.9% to 3.3% in 2026/27.

d) Amendments are further proposed to the public fire protection charge to the Municipality. The current annual fire protection charges by each of the existing water utilities of Windsor and West Hants to the Municipality and the public fire protection received by other parties by the Municipality have an estimated combined total of \$1,070,092. It is proposed to increase to \$1,434,006 (a 34% increase) in 2024/25; \$1,729,659 (a 21% increase) in 2025/26; and \$1,760,699 (a 2% increase) in 2026/27.

Upon reviewing the Application, the Board, in its Decision, may determine that the proposed amendments should be as requested, higher, or lower.
