witnesses. Your request must be received by the Board by **Tuesday**, **April 29**, **2025**, and a copy of your written evidence by **Friday May 23**, **2025**.

#### Additional information about the matter is as follows:

- For unmetered service, based upon quarterly consumption of 30 cubic metres, the current quarterly water bill is \$136.56, and it is proposed to decrease to \$135.90 (0.5%) in 2025/26; then increase to \$148.35 (9.2%) in 2026/27; and \$156.26 (5.3%) in 2027/28.
- For a 5/8" meter, residential customer, the average current quarterly water bill is \$148.02, and it is proposed to increase to \$159.82 (8.0%) in 2025/26; \$176.67 (10.5%) in 2026/27; and to \$186.13 (5.4%) in 2027/28.
- The Utility is also requesting increases for other metered services ranging from 4.7% to 19.8% in 2025/26; 9.1% to 15.7% in 2026/27; and 5.4% to 5.5% in 2027/28.
- The annual fire protection charge to be paid by the Town of Middleton, currently \$276,410, is proposed to increase to \$305,911 (10.7%) in 2025/26; \$406,930 (33.0%) in 2026/27; and to \$445,802 (9.6%) in 2027/28.

Upon reviewing the Application, the Board, in its Decision, may determine that the proposed amendments should be as requested, higher, or lower.
