**ORDER**

Pursuant to its *Discount Review* Decision [2015 NSUARB 33], the Board has approved the addition of a Generic Fuel Adjustment Mechanism (FAM) to the following licenses:

Windsor Senior Citizens Bus Society o/a The Community Bus N.S. - Motor Carrier License Nos. P03188 and P02778 (Diesel);

Markie Bus Tours - Motor Carrier License No. P01922 and Extra-Provincial Operating License No. XP02441 (Diesel and Gasoline); and

**DIESEL**

The FAM operates as a surcharge calculated at 1% for every 5 cents per litre that the average monthly Wholesale Diesel (Rack) Price in Halifax varies from the base fuel price of \$0.65/litre, as tracked by Kalibrate for Diesel (ULSD). The FAM is calculated by reviewing the fuel prices between the 16<sup>th</sup> of one month to the 15<sup>th</sup> of the next month.

For the period ended June 15, 2024, the average monthly Wholesale Diesel (Rack) Price in Halifax exceeded the base fuel price by 56.66 cents per litre, resulting in an 11.0% Diesel FAM surcharge.

## **GASOLINE**

The FAM operates as a surcharge calculated at 1% for every 5 cents per litre that the average monthly Wholesale Gasoline (Rack) Price in Halifax varies from the base fuel price of \$0.57/litre, as tracked by Kalibrate for Gasoline. The FAM is calculated by reviewing the fuel prices between the 16<sup>th</sup> of one month to the 15<sup>th</sup> of the next month.

For the period ended June 15, 2024, the average monthly Wholesale Gasoline (Rack) Price in Halifax exceeded the base fuel price by 58.26 cents per litre, resulting in an 11.0% Gasoline FAM surcharge.

For the purposes of the current month, the average monthly Rack Price for both gasoline and diesel includes the federal fuel charges (carbon tax) starting July 1, 2023.

### **The Board orders that:**

- 1) A Diesel FAM surcharge of 11.0% is approved for the Schedule D Rates of the licenses, effective on and after 12:01 A.M., July 1, 2024.
- 2) A Gasoline FAM surcharge of 11.0% is approved for the Schedule D Rates of the licenses, effective on and after 12:01 A.M., July 1, 2024.
- 3) The FAM surcharge shall remain in effect until such time as it is amended or terminated by the Board.
