AND WHEREAS the Board revised the retail margin and transportation allowance effective January 6, 2012, in its Decision, 2011 NSUARB 181, issued on November 23, 2011;

AND WHEREAS the Board revised the wholesale margin effective

January 4, 2013, in its Decision, 2012 NSUARB 213, issued on December 12, 2012;

AND WHEREAS the average of the average of the daily high and low

reported product prices (in Canadian cents) for the week ended February 17, 2016 are:

Grade 1 Regular gasoline 37.0¢ per litre Ultra-low sulfur diesel oil 37.5¢ per litre

NOW THEREFORE the Board prescribes the benchmark prices for

petroleum products to be:

Gasoline:	
Grade 1	37.0¢ per litre
Grade 2	40.0¢ per litre
Grade 3	43.0¢ per litre
Ultra-low sulfur diesel oil	37.5¢ per litre

AND NOW THEREFORE the Board has determined, based on historical

data regarding price changes and to achieve revenue neutrality, it is appropriate to

apply, and the Board so orders, forward averaging corrections of:

Gasoline: minus 1.2¢ per litre Ultra-low sulfur diesel oil: Nil.
